## VISHNU MANDIR KARNAL - PERSONAL DATA PROTECTION POLICY

### 1. Introduction

This Personal Data Protection Policy ("Policy") sets out the ways in which **Vishnu Mandir Karnal** ("VMK", "we", "our", or "us") collects, uses, discloses, and retains personal data in order to carry out our activities and operations, and the measures we take to protect your personal data. The Policy is designed to meet the requirements of India's personal data protection laws.

- **d)** Financial information such as bank account details, payment history, and income details;
- **e)** Information about your interactions with our website and services, such as device capability, bandwidth, and page views.

### 4. How We Collect Your Personal Data

We collect personal data through various methods, including but not limited to:

- **a)** When you register for events, activities, or ceremonies at **Vishnu Mandir Karnal**;
